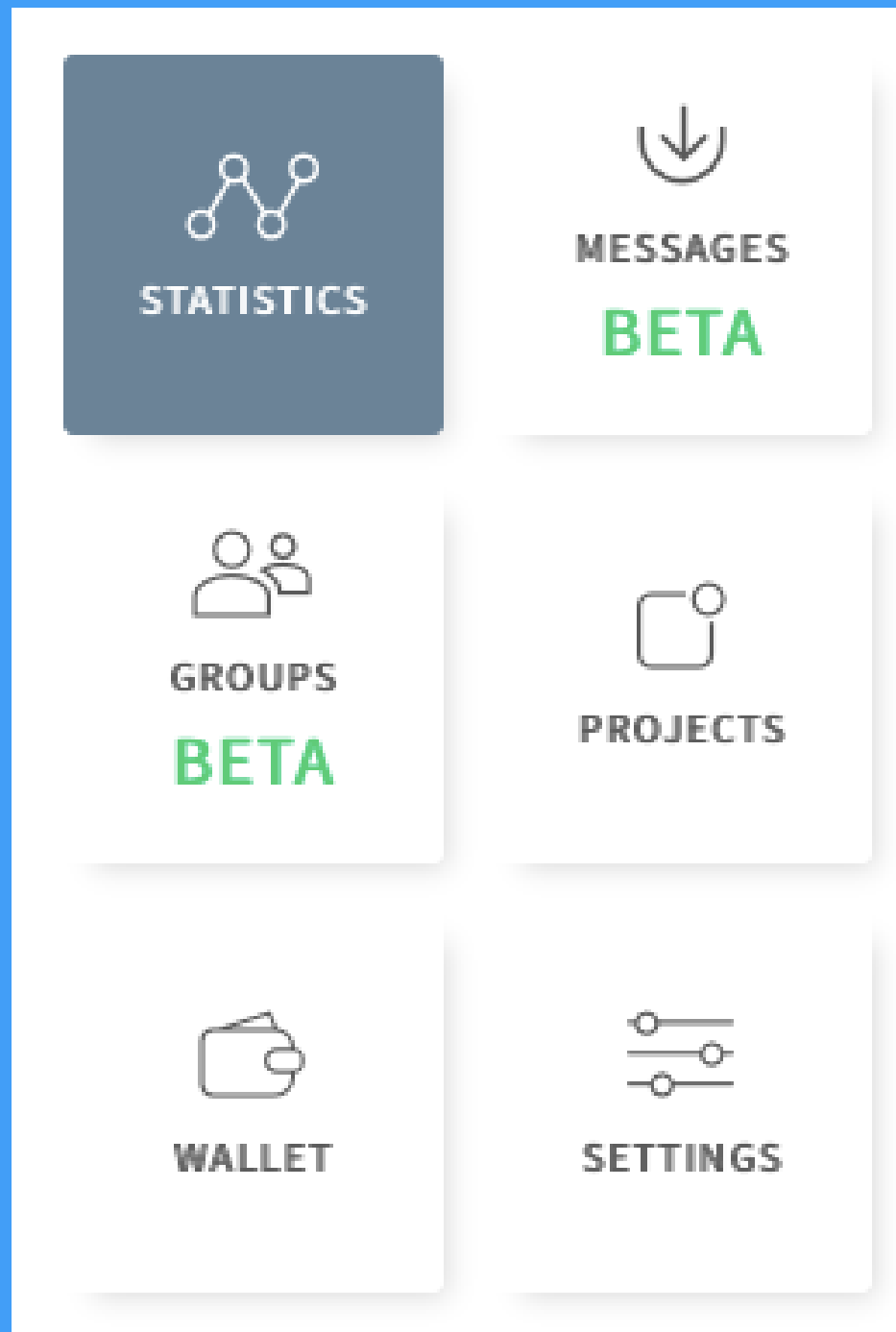
Switching Profiles.

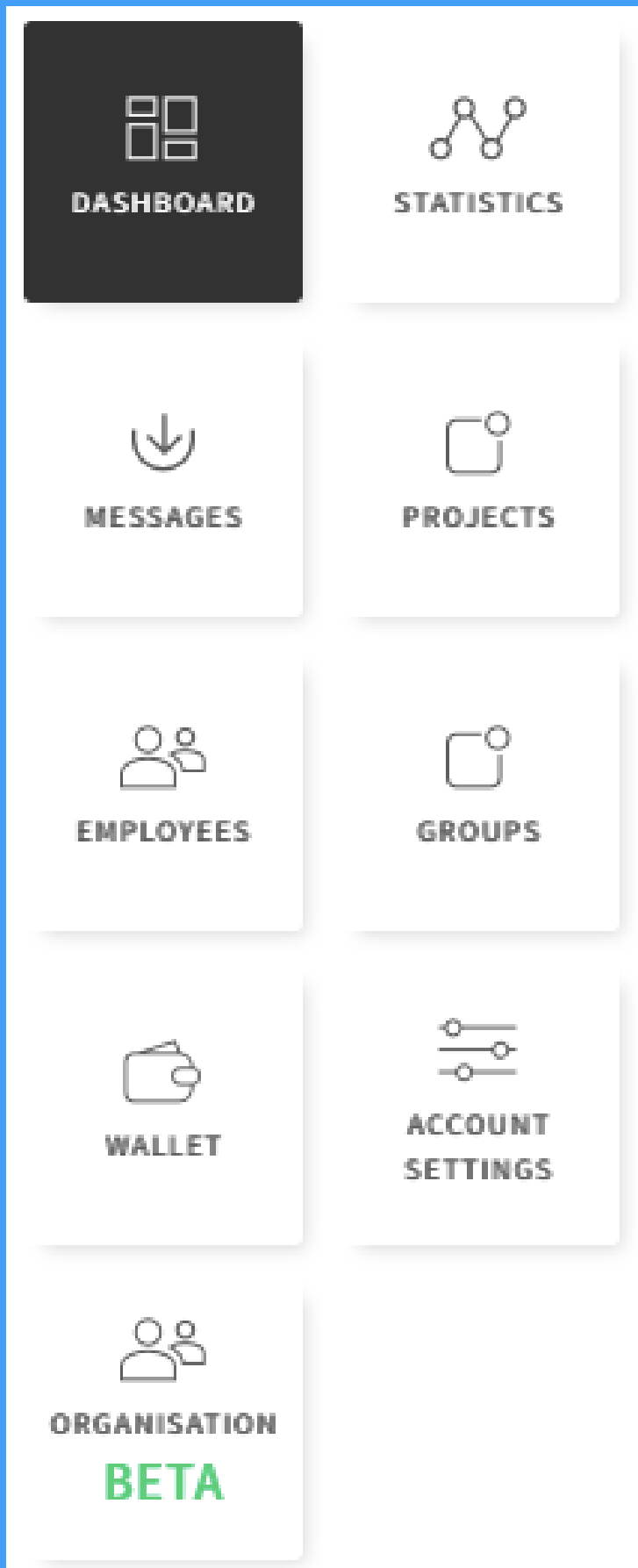

Wallet - This is where you upload money into your wallet to donate.

Settings - This is where you change your account settings such as picture, address etc.

Organisation - This is your organisation structure, it breaks down into very simple terms your employees, funds raised, hour volunteered etc.
